

PREA and Victim Services: A Trauma-Informed Approach Notification of Curriculum Utilization October 2014

The enclosed *PREA* and *Victim Services: A Trauma-Informed Approach* curriculum was developed by Just Detention International (JDI) as part of contract deliverables for the National PREA Resource Center (PRC), a cooperative agreement between the National Council on Crime and Delinquency (NCCD) and the Bureau of Justice Assistance (BJA). The Prison Rape Elimination Act (PREA) standards served as the basis for the curriculum's content and development, with the goal of the *PREA* and *Victim Services: A Trauma-Informed Approach* curriculum being to satisfy specific PREA standard requirements.

It is recommended that the *PREA* and *Victim Services: A Trauma-Informed Approach* curriculum be reviewed in its entirety before choosing which modules to use. Any alterations to the original materials must either be acknowledged during their presentation or have the PRC and JDI logos removed.

BJA is currently undergoing a comprehensive review of the enclosed curriculum for official approval, at which point the BJA logo may be added.

PREA Standards as a Tool

The PREA Standards

- Offer guidance for a trauma-informed, coordinated response
- Recognize that sexual abuse and harassment require a different response than other critical incidents
- Require a multidisciplinary team including:
 - Staff first responders;
 - Medical and mental health practitioners;
 - Investigators; and
 - Facility leadership.

§115.5 General Definitions

Confined Individuals are

- Inmates in adult prisons and jails
- Detainees in lockups
- Residents of juvenile or community confinement facilities





§115.6 Definitions Related to Sexual Abuse

- Sexual abuse includes a range of non-consensual sexual behaviors of an inmate, detainee, or resident by another inmate, detainee, or resident or by a staff member, contractor, or volunteer
- Sexual Harassment includes repeated and unwelcome sexual advances, requests for sexual favors, or verbal comments, gestures, or actions of a derogatory or offensive sexual nature by one inmate, detainee, or resident directed to another and by staff, contractors, or volunteers.





Relevant Victim Services Standards

- Facilities shall try to make a victim advocate from a rape crisis center available to provide confidential support services to a victim (§115.21(d))
- Inmate access to outside confidential support services (§115.53)
- Agreements with community service providers (§115.53(c))
- Immediate steps when inmate is at substantial risk of imminent sexual abuse (§115.62)





Additional Relevant Victim Services Standards

- Institutional coordinated response plans (§115.65)
- Protecting staff and inmates from retaliation for reporting sexual abuse or cooperating with investigations (§115.67(a))
- Emergency and ongoing medical & mental health care for the victim (§115.82; §115.83)
- Ongoing medical and mental health care for sexual abuse victims and abusers (§115.83)
- Sexual abuse incident reviews (§115.86)





Applying the PREA Standards on Victim Services

Core Components

§115.21 Uniform Evidence Protocol:

- The plan must maximize the potential for useable evidence
- Victims must have access to forensic medical examinations
- The agency shall document its efforts to provide a qualified SAFE or SANE

Applying the PREA Standards on Victim Services

Core Components

§115.65 Coordinated Response:

- The facility shall develop a written institutional plan to coordinate actions in response to an incident of sexual abuse
- The plan includes staff first responders, medical and mental health practitioners, investigators, and facility leadership
- The plan frames the facility response and gives staff members tool to handle disclosures effectively





Applying the PREA Standards on Victim Services

Core Components

§115.53(c) and §115.21(d) Memoranda of Understanding

- The agency shall maintain or attempt to enter into an MOU with a community service provider that can offer confidential support services related to sexual abuse
- The corrections facility must make available a victim advocate from a rape crisis center. If a rape crisis center is not available, a qualified staff member from another community organization or a qualified agency staff member can be made available

Interpreting the PREA Victim Services Standards

Corrections Must Offer Services to Inmates Who Report

- Emergency medical and mental health care
- Forensic evidence collection, as appropriate
- Preventive measures such as pregnancy and HIV/AIDS tests
- Accompaniment by advocate for the victim
- Services must be free and provided whether the victim names the abuser or not





Putting Policy Into Practice

Jose's Story

- 25 years old
- Former gang member
- Works as a porter
- Threatened and sexually abused by two former rival gang members







First Responder Duties


Security Staff

- Ensures victim's safety
- Separates victim and abuser
- Preserves the crime scene and any potential evidence
- Notifies the investigator
- Escorts victim to the clinic





Emergency Medical Response



Facility Medical Staff

- Collects basic information
- Assesses for injuries and suicide risk
- Administers first aid
- Preserves evidence
- Informs the investigator of any injuries





Rape Crisis Advocate Duties

Advocate

- Provides confidential support, information, and referrals
- Accompanies victim during the exam and interviews
- Maintains confidentiality

ER Medical and Mental Health Care and Forensic Exam

Sexual Assault Nurse Examiner

- Coordinates the forensic exam
- Obtains informed consent
- Conducts the exam
- Provides medical care and prophylaxis
- Offers referrals and discharge instructions
- Collects and preserves evidence
- Gives the "rape kit" to the detective





Benefits of the Institutional Coordinated Response Plan

The Institutional Coordinated Response Plan Can Also Be a Model for

- Multiple mechanisms for reporting
- Steps to take when an inmate is at risk
- Protecting staff and inmates from retaliation for reporting
- Incident reviews





Wrap-Up Discussion

- Emergency and ongoing medical and mental health care
- Confidential access to rape crisis advocates
- Victim notification
- Protection from retaliation
