INSTRUCTIONS

INMATE NAME AND CDC NUMBER - Obtain from the Legal Status Summary (LSS).

SCREENING LOCATION - Indicate where the SVP case was screened (e.g., Institution, Parole Region/Unit, or County Jail).

PAROLE USE ONLY - Concerns Pending Revocation (PEND REV) cases. Indicate the date of the parole hold.

CRIMINAL IDENTIFICATION AND INFORMATION (CI&I) NUMBER - Obtain from the CI&I (California Law Enforcement Teletype System-CLETS) printout, the Probation Officer's Report (POR) or from the COFQ query in the Offender Based Information System (OBIS).

COUNTIES OF PRESENT COMMITMENT - Obtain from the LSS or the Abstracts of Judgment (AOJ). If there are multiple, list all.

DISCHARGE/ARCHIVE NUMBER(S) - Obtain from the POR, CI&I, COFQ/OBIS. Request file if additional information is needed.

RELEASE DATES - Obtain release date information from the CDC Form 112, Chronological Inmate History. Include all dates that are available, and if necessary, include "estimated" dates. If release date is estimated, note, i.e. **12/21/08 (EST)**. Parole regions are also responsible for including any available release date information.

QUALIFYING OFFENSES - Review AOJ, POR, CI&I (CLETS), Multistate and FBI rap sheets for felony convictions for a WIC Section 6600 qualifying offense. Include Mentally Disordered Sex Offender (MDSO) convictions/findings and specific Not Guilty By Reason of Insanity findings associated with a qualifying offense. Include all qualifying convictions that were dismissed, expunged or absolved via a "Certificate of Rehabilitation" pursuant to PC Section 1203.4. Include all Juvenile convictions wherein the offender was convicted as an adult. NUMBER OF CONVICTED COUNTS - For any specified offense(s). Obtain from the AOJ, LSS, POR, CI&I, FBI or Multistate.

NUMBER OF STAYED COUNTS - For any specified offense(s). Not reflected on the LSS. Obtain from the AOJ or POR.
