## Wyoming Department of Corrections Male Internal Classification System

- A. Purpose: The Wyoming Department of Corrections Internal Classification System is used to determine the appropriate housing assignment for the inmate. The purpose is to differentiate among inmates with respect to their potential for aggressive behavior and vulnerability to sexual assault. It primarily functions to systematically determine to which housing unit the inmate assigned. If the inmate is appropriate for general population, it also serves to identify the type of inmate with which the inmate should be housed. The housing assessment is similar to the custody assessment, but places greater emphasis on the inmate's predatory behavior and vulnerability.
- **B.** Completion Policy: An Internal Classification Form must be completed during the Assessment and Orientation (A&O) process before the inmate is transferred to a general population housing unit and cell. Completion of an Internal Classification Form is <u>not</u> required in order to transfer an inmate between housing units or cells, if his aggression category has not changed. However, any transfer of an inmate, except intra-cell moves, requires the written approval of the warden/designee. In sum, the Internal Classification form must be completed:
  - 1. Intake Upon admission, before the inmate is moved from the A&O housing unit;
  - 2. Post Disciplinary Review Upon finding guilt for an aggressive or predatory disciplinary infraction (See Appendix B for listing of predatory and aggressive institutional infractions.); or
  - 3. New Information Upon receipt of new information regarding one or more of the aggression or vulnerability factors other an institutional disciplinary report.

## C. Instructions:

#### I. Identification

<u>Name</u>: Enter the inmate's full name, i.e., last name followed by first name and middle initial.

<u>WDOC ID#</u>: Enter the inmate's current DOC number that was assigned during the A&O process.

<u>Final Custody Level</u>: Enter the final custody level of the inmate at the time of this assessment.

Date of Assessment: Enter the month, day, and year of this aggression assessment.

<u>Current Aggression Category</u>: Enter the inmate's aggression category (Altus, Medius, or Brevis). If an aggression assessment has not been completed, Enter, "initial assessment."

<u>Current Vulnerability Category</u>: Enter the inmate's vulnerability designation (Known Victim, Potential Victim, or Non-Victim). If a vulnerability assessment has not been completed, Enter, "initial assessment."

<u>Type of Classification Assessment</u>: Enter the reason for the current housing assessment as defined by the completion policy described above.

- **II. Aggression Assessment:** Enter the score that best describes the inmate for each of the five (5) aggression factors. Consider the inmate's convictions, age, institutional conduct, sexual behavior, Static 99 score, identified Core Northpointe Compas responses, and security threat group involvement.
  - Most Serious Felony Conviction: Consider all current felony convictions and any prior felony conviction during the last 10 calendar years to determine the most serious conviction. If the inmate was convicted of conspiracy, accountability or a violation of parole/probation, the severity of the conviction is based on the underlying offense(s) of which the inmate was originally convicted. (See the Severity of Offense Index located in Appendix A.) Use the date of conviction of the prior convictions to determine if the conviction occurred during the last 10 calendar years. Juvenile convictions cannot be scored on this section unless tried as an adult.

Enter the number of points associated with the severity category into which the inmate's most serious felony conviction falls. For example:

- The inmate was convicted eight (8) years ago of aggravated assault and the current conviction is burglary, score the aggravated assault.
- The inmate was convicted 12 years ago of aggravated assault and the current conviction is burglary, score the burglary.
- The inmate has been incarcerated for 20 years for an aggravated assault, score the aggravated assault.

Enter **3** if the most serious conviction is of **Highest** or **High** severity.

Enter 1 if the most serious conviction is of Moderate severity.

Enter **0** if the most serious conviction is of **Low** severity.

2. Current Age: Consider the age of the inmate at the time of this housing assessment.

Enter **3** if the inmate is age less than or equal to 27.99 years.

Enter **1** if the inmate is age 28 to 46.99 years.

Enter **0** if the inmate is age 47 or more years.

3. Institutional Behavior during the last 60 months: Consider the disciplinary infractions of which the inmate was found guilty during the last 60 months. Consider disciplinary reports from prior incarceration(s) as well as the current incarceration to determine if he was found guilty of a predatory or major disciplinary infraction. (See Appendix B for a listing of the Wyoming DOC disciplinary infractions by severity and Appendix C for the ACC Code of Discipline.)

Disciplinary infractions that occurred in a jail should be counted if a description of the behavior(s) and documentation of a disciplinary/administrative review of the incident indicates the inmate was guilty of the behavior are available.

Compute time since the infraction as the date of this assessment minus the date of the finding of guilt for the infraction.

Enter **8** if the inmate received three or more Predatory DRs (3+) during the last 60 months.

Enter **8** if the inmate received one or more Predatory DRs (1+) during the last 12 months.

Enter 5 if the inmate received two Predatory DRs (2) during the last 13 to 60 months.

Enter 3 if the inmate received one Predatory DR (1) during the last 13 to 60 months.

Enter **3** if the inmate received 2+ Major, non-predatory disciplinary reports during the last 12 months.

Enter **2** if the most serious disciplinary report received by the inmate during the last 36 months was an Aggressive infraction. Sexual Aggression Infractions include:

Enter **0** if the most serious disciplinary report received by the inmate during the last 60 months was a Minor, non-aggressive General, or non-aggressive Major infraction.

4. Aggressive Interactions: This risk factor requires consideration of the inmate's Core Northpointe Compas Assessment. There are two elements – cognitive behaviors and isolation. Cognitive behavior is based on the inmate's responses to eight questions while the Isolation element considers his responses to four questions. If the Compas Assessment indicates the response to a question maybe unreliable, score the question as 1 point. Re-interviewing the offender is <u>not</u> required for the custody assessment.

**Cognitive Behavior:** Consider the inmate's responses to the following questions on the Core Northpointe Compas assessment. Points for this risk factor are based on the number of behaviors that the inmate scores as 1 using the following grid:

**Isolation:** Consider the inmate's responses to the following questions on the Core Northpointe Compas assessment. Points for this risk factor are based on the number of indicators that the inmate scores as 1 using the following grid:

Enter **3** if the inmate's cognitive behavior total score is greater than or equal to 6(6 - 8).

Enter **3** points if the inmate has not completed a Core Northpointe Compas Assessment or he refuses to complete an assessment.

Enter **2** if the inmate's isolation total score is 4 and his cognitive behavior total score is 0 - 5.

Enter **0** if the inmate's cognitive behavior total score is 0 - 5 and his isolation total score is 0 - 3.

5. Institutional Aggression: Consider the inmate's involvement with institutional security threat group activity, sexual behavior, and Static 99 score. These behaviors may be indicated by disciplinary infractions, intelligence gathered by the security threat group coordinator, pre-sentence investigation report, self-report information regarding conflicts, etc. If more than one category is applicable to the inmate, score the highest category. For example, if the inmate's response to Static 99 question no. 10 – is yes (Any Male Victims?) and he has been validated as a member of a security threat group, score according to the security threat group membership (4 points).

Enter **6** if the inmate has documented institutional sexual activities during the last 60 months including:

- Pre-2010 disciplinary report for MJ35 or MJ36;
- 2010 Disciplinary Code MJ19 or MJ19P; and/or
- Documented institutional incident report/investigation for sexual aggression.

Enter **4** if the inmate has documented security threat-group or gang-related behavior while incarcerated during the last 60 months including:

- Pre-2010 disciplinary report for GN18 or MJ17;
- 2010 Disciplinary Code MJ18 or MJ18P;

- Validated as a Security Threat Group Member; and/or
- One or more (1+) conflict due to "STG Affiliation".

Enter 2 if a Static 99 has been completed for the inmate and the response to question no. 10 "Any Male Inmates?" was "Yes."

Enter 1 if the inmate is suspected of being a member of a security threat group or he was previous a member but has renounced his membership.

Enter **0** if there are no institutional aggression indicators applicable to this inmate.

### III. Aggression Category

**Total Aggression Score**: Sum of the scores for the five aggression factors and enter the total on the line provided.

**Aggression Scale:** Based on the inmate's total aggression score, determine the inmate's aggression category according to following scale:

Altus:	High Aggression	9 or more points
Medius:	Moderate Aggression	6 to 8 points
Brevis:	Low Aggression	0 to 5 points

- IV. Aggression Override Criteria: This section is designed to address management issues that warrant attention and possible intervention that have not reflected adequately in the designated unit. The presence of one or more of these factors <u>may require</u> modification of the unit assignment for the inmate. Enter the override factor(s) applicable to this inmate:
  - 1. Sexual Behavior/Orientation The inmate's sexual orientation and/or institutional behavior suggests that he is inappropriate for the designated housing unit because he constitutes a danger to others because of his predatory behavior or he may be vulnerable.
  - 2. Developmental Disability/Delay The inmate is incapable of functioning in any housing area other than a highly structured treatment environment because he constitutes a danger to himself or because of difficulty interacting with others due to limited comprehension and/or communication skills. Education and/or mental health staff should be consulted to determine the need for special housing. One indicator of developmental disability is a Gama Profile Score less than or equal to 79.
  - 3. Language Barrier The inmate does not speak or comprehend English and thus is unable to understand the activities and rules within the unit, or would be vulnerable to victimization.
  - 4. Age/Size The inmate maybe be vulnerable due to his size and/or age.
  - 5. Mental Health The inmate has been examined by mental health staff and found to be incapable of functioning in any housing area other than a highly structured

treatment environment because he constitutes a danger to himself or because he may have difficulty interacting with others because of his condition(s). Mental health staff should be consulted to determine the need for close watch and/or ongoing mental health services. Specify the mental health concern on the line provided.

- 6. Medical Medical staff has examined the inmate and his treatment requires special housing or supervision. This includes inmate who have been diagnosed by medical staff as having a communicable disease or a physical impairment that requires special housing or supervision. This override also includes inmate with temporary or permanent disabilities that render at low risk for aggression. Medical staff should be consulted to determine his need for close watch and/or ongoing medical services. Specify the medical concern on the line provided.
- **7. 1**<sup>st</sup> **Institutional Incarceration/Naiveté** Inmate is unaware and unsophisticated with regard to prison culture and therefore is not prepared to cope with precarious situations and relationships within the prison environment.
- 8. Other These are special circumstances indicated by the inmate's behavior, criminal history, needs, or medical/mental health status that have not been addressed adequately and warrant his placement in a living unit other than that indicated by the standard housing criteria. Specify the override reason(s) on the line indicated and attach all documentation as to the nature, source, and date the information was received.

## V. Aggression Category

After reviewing the aggression category and all information that may justify an override, Enter the aggression category. This will be the same as the scored aggression category, if no override is recommended.

## VI. Vulnerability Factors

This section of the housing assignment forms contains factors that are to be used to designate the inmate as a known victim, potential victim, or non-victim. For each factor the screener must list the source(s) used to make the assessment. In conducting this assessment, the screener shall review the appropriate screens within WCIS and conduct an interview with the inmate in a private setting.

- Victim of prison rape or sexual assault past 10 years: Check "yes" if there is any formal documentation that the inmate has a history of being raped or sexually assaulted while incarcerated in any correctional facility as either an adult or juvenile. Self reported allegations by the inmate are NOT to be used for this factor, but should be referred to the appropriate investigative unit and considered as a possible override factor.
- **2.** Age: Check "yes" if the inmate is under the age of 22 years or 62 years or older at the time of this assessment based on the inmate's official date of birth.
  - Compute as Date of Assessment DOB.

- **3.** Small physical stature (5'6" or less and/or less than 140 lbs): Check "yes" if the inmate's medical record indicates he is 5'6" or less and/or weighs less than 140 pounds.
- 4. Developmental disability/mental health: Check "yes" if the inmate has a mental need or condition that might make him vulnerable within a general population setting.
- 5. Incarcerated Less than 90 Days: Check "yes" if the inmate has been incarcerated less than 90 days in a state or federal correctional facility. This must be based on formal records or criminal history report.
- 6. Gay, bi-sexual, transgender, and/or overtly effeminate: Check "yes" if the inmate states that he is homosexual/gay, bi-sexual, and/or undergoing a trans-gender process. The overtly effeminate attribute is limited to males and is based on staff observation of the inmate plus a similar notation in at least one other source document.

If an inmate has sexual relations with another male inmate in prison, he should NOT automatically be considered gay for this vulnerable factors - The sexual activity/ relations should be counted as a Yes for No. 8 -- History of sexual activities while incarcerated within 10 years. Note, this behavior would also be counted for Aggression Factor No. 5. Institutional Aggression.

Sex offenders with a male victim(s) should be considered gay/bi-sexual. The offense(s) description(s) serve as the source document. He may be bi-sexual rather than gay, but nonetheless, score as yes for gay, bi-sexual, transgender, and/or overtly effeminate. Note a sex offender with a male victim(s) would also be counted for Aggression Factor No. 5. Institutional Aggression -- "Any male victims?"

- 7. History of sexual abuse in past 10 years: Check "yes" if there is any indication in any documents that the inmate has been sexually abused in a setting, other than a correctional institution, or if the inmate self-reports as being sexually abused in a setting other than a correctional institution. Such an admission may require notification of the report to the appropriate investigative agency.
- 8. History of sexual activities while incarcerated within 10 years: Check "yes" if there is any documentation that the inmate has been involved in sexual activity in any correctional setting (adult or juvenile) or if the inmate self-reports involvement in sex activities in any correctional setting (adult or juvenile).
  - Consider disciplinary history guilty of New Disciplinary code MJ-19 or MJ-19P or Pre-2010 Disciplinary codes MJ35 or MJ36, and/or a PREA investigation for these disciplinary infractions.
- **9. Protective custody within 10 years:** Check "yes" if there is a documented history within the past 10 years of the inmate being placed in protective custody in an adult or juvenile correctional facility. Consider placement in Long-Term Administrative Segregation-Special Management (LTASSM) well as placement in Protective Custody.
  - Compute "within 10 years" as Date of Assessment Date of exit from protective custody/LTASSM. Indicate date of most recent exit from protective custody/LTASSM in the "Comments/Source" box for this question.

#### VII. Vulnerability Designation Process

Based on the inmate's vulnerability score, determine the inmate's vulnerability designation according to the following scale:

**Known Victim** - If item 1 is checked as "Yes," the inmate shall be designated as a "Known Victim" of sexual assault or rape.

**Potential Victim** - If two or more items 2 – 9 are checked as "Yes," the inmate shall be designated as a "Potential Victim."

**Non-Victim** - If one or none of the items 2 - 9 is checked as "Yes." the inmate shall be designated as "Non-Victim" indicating that he is neither a known or potential victim of prison rape or sexual assault.

**Scored Designation**: Enter the vulnerability designation derived from the vulnerability scale.

### VIII. Vulnerability Override

Check the appropriate box to indicate yes or no as to whether an override of the scored designation is recommended. The scored "potential victim" or "Non-Victim" designation <u>can</u> be over-ridden as follows:

- A "Potential Victim" designation can be over-ridden to a "Non-Victim" designation; or
- A "Non-Victim" designation can be over-ridden to a "Potential Victim" designation.

#### An over-ride cannot be used to designate someone as a "Known Victim."

**Rationale for change/override:** Whenever an override is used, the basis for the override **MUST** be indicated on the form.

**Final Designation**: Enter the vulnerability designation after consideration of any potential override factors.

#### **IX. Conflicts**

Consider any separation requirements between this inmate and other inmates and/or staff due to conflicts associated with previous institutional or jail incidents, victims, co-defendants, family, security-threat group involvement, nature of crime, prior employment, etc.

If there are no substantiated conflicts between the inmate and other inmates or staff, enter, "None Reported or Noted."

Indicate the name(s) (first and last), WDOC number(s) of the inmates/staff with whom the inmate has a conflict, current location (facility, unit, and pod), the reason(s) for, and the status of the conflict.

Housing conflict reasons include: Co-defendant, victim, STG affiliation, witness, institutional behavior, or other. Indicate the specific "other" reason(s).

Status of the conflict should be coded as: A or Active or R or Resolved.

## X.Unit and Pod Placement

**Unit and Pod Placement Matrix** – The primary criteria for assigning an inmate to a living unit are outlined in the Unit and Pod Placement Matrix.

**External Custody Level** – Consider the inmate's final custody from the most recent classification assessment—Maximum, Close/Restricted, Close/GP, Medium, Minimum-Restricted, or Minimum.

**<u>Aggression Category</u>** – Based on the Aggression Scale, select the column according the inmate's aggression category.

<u>Vulnerability Designation</u> – Select the column according the inmate's Vulnerability Designation.

**Unit Placement:** Determine the unit appropriate for the inmate based upon his external custody level, aggression category, and vulnerability designation.

### **WSP Housing Unit Placements:**

**WSP Unit A-1:** Place in this unit the following inmates:

- Close-Restricted, Close-GP, or Medium custody inmates identified as Altus-Non-Victim; OR
- Close-Restricted, Close-GP, or Medium custody inmates identified as Medius

   Non-Victim.

**WSP Unit A-2:** Place in this unit the following inmates:

- Close-Restricted, Close-GP, or Medium custody inmates identified as Medius; OR
- Close-Restricted, Close-GP, or Medium custody inmates identified as Brevis.

WSP Unit B-1: Place in this unit the following inmates:\*\*\*\*

- Medium, Minimum-Restricted, or Minimum custody inmates identified as Medius; OR
- Minimum-Restricted or Minimum custody inmates identified as Altus-Non-Victim.

\*\*\*\*Do NOT house a Medius-Potential/Known Victim and an Altus/ NonVictim in B-1 simultaneously. If an Altus/ NonVictim is housed in B-1, do not house a Known Victim/Potential Victim in the unit.

WSP Unit B-2: Place in this unit the following inmates:

 Close-Restricted, Close-GP, or Medium custody inmates identified as Altus-Non-Victim; OR • Close-Restricted, Close-GP, or Medium custody inmates identified as Medius.

WSP Unit C-1: Place in this unit the following inmates:\*\*\*\*

- Close-Restricted, Close-GP, Medium, Minimum-Restricted, or Minimum custody inmates identified as Altus Known/Potential Victim: OR
- Close-Restricted, Close-GP, or Medium custody inmates identified as Medius.

\*\*\*\*Provide single cells with direct supervision during out time for Altus Non-Victim and Altus Known Victim/Potential Victim.

WSP Unit C-2: Place in this unit the following inmates:

- Medium, Minimum-Restricted, or Minimum custody inmates identified as Medius; OR
- Medium, Minimum-Restricted, or Minimum custody inmates identified as Brevis.

WSP Units E-1-3: Place in this single-cell unit the following inmates:

- Maximum custody inmates identified as Altus, Medius, or Brevis.
  - Provide single cells with no mixing during out time for Altus Non-Victim with Altus Known Victim/Potential Victim;
  - Ensure no mixing during out time for Altus and Brevis; and
  - Medius and Brevis do not require single cells.

**WSP Unit K-1:** Place in this unit the following inmates:

 Medium, Minimum-Restricted, or Minimum custody inmates identified as Medius OR Brevis.

**WSP Unit K-2:** Place in this unit the following inmates:

• Medium, Minimum-Restricted, or Minimum custody inmates identified as Medius OR Brevis.

## WMCI Housing Unit Placements:

**WMCI Units D1-2:** Place in this unit the following inmates:

• Medium custody inmates identified as Medius.

**WMCI Units D3:** Place in this unit the following inmates:

- Medium custody inmates identified as Medius or Brevis;
- Minimum-Restricted identified as Medius.

WMCI Unit 6: Place in this unit the following inmates:

- Medium custody inmates identified as Medius or Brevis;
- Minimum-Restricted custody inmates identified as Medius or Brevis; OR
- Minimum custody inmates identified as Medius or Brevis.

WMCI Unit D7: Place in this unit the following inmates:

- Minimum-Restricted custody inmates identified as Medius or Brevis; OR
- Minimum custody inmates identified as Medius or Brevis.

**Recommended Housing Placement** On consideration of the inmate's custody level, aggression category, vulnerability designation, and conflicts, the case manager has the option to recommend a unit, pod, and/or cellmate for the inmate. If an override or conflict is not indicated or does not warrant deviation from the Unit and Pod Placement Matrix, the pod and unit must be that indicated by the Unit and Pod Placement Matrix.

**Housing needs:** Indicate if the inmate requires a bottom bunk, handicapped-equipped cell, and/or single cell and provide the rationale for recommending a bottom bunk, handicapped-equipped cell, and/or single cell in the comments section.

**Case Manager:** Upon completion of the housing assignment form, the staff must sign and date the form.

**Comments:** Provide additional comments, explanation, or documentation of the information used to determine the recommended unit, pod, cell, and/or housing needs recommended for the inmate.

#### XI. Housing Assignment

On consideration of the inmate's custody level, aggression category, vulnerability designation, and conflicts, the institutional housing manager will identify the appropriate unit and pod for the inmate. If an override or conflict is not indicated or does not warrant deviation from the Unit and Pod Placement Matrix, the pod and unit should be that indicated by combining the inmate's external custody level. aggression category, and vulnerability designation.

**Housing Needs:** Indicate if the inmate requires a bottom bunk, handicapped-equipped cello and/or single cell and provide the rationale for recommending a bottom bunk, handicapped-equipped cell, and/or single cell in the comments section.

**Housing Manager:** The completed housing assignment form must be signed and dated by the housing manager or his/her designee indicating approval of the recommended aggression category, review of any conflicts, and the assignment of the inmate to a unit, and pod.

**Comments:** Provide additional comments, explanation, and/or documentation of the information used to assign the inmate to a housing unit, pod, and housing needs required for the inmate.

Each offense in the Wyoming Penal Code has been ranked according to its severity for the purposes of the WDOC Classification System. Score the offense for which the inmate was incarcerated/convicted.

**Exceptions:** For the following offenses, score the underlying offense:
